- ▶ **BBB+, stable outlook credit rating** (S&P)

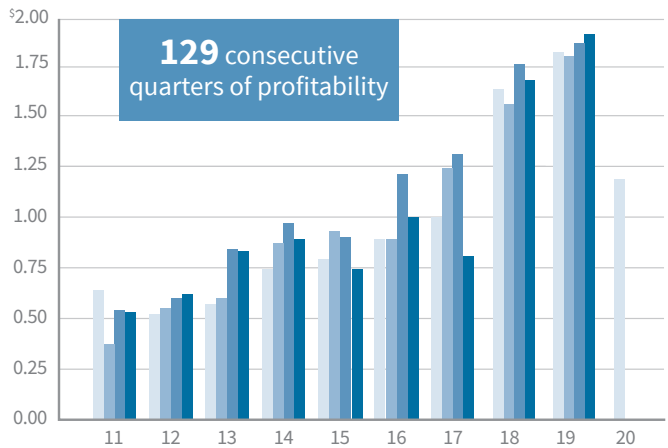
## DID YOU KNOW?

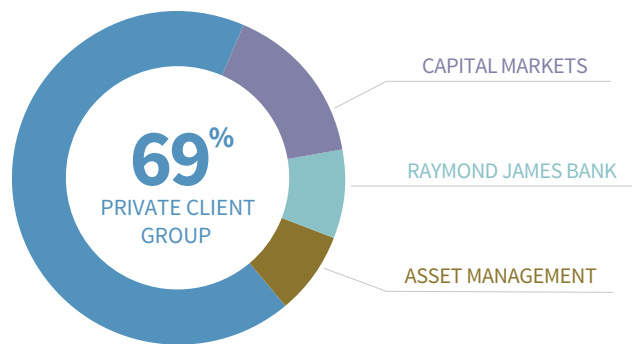
Diluted quarterly earnings per share
